### 1 Introduction and purpose

This drug policy is applicable for the whole of Telge United FF and the purpose is to support the board, managers, players and others who work within Telge United FF. The ambition is that the policy should be seen as a guiding and supporting document.

#### 1.1 Definitions

Definition	Description
Drugs	Drugs are defined as alcohol, drugs and doping-class products.
The	World Anti-Doping Agency is a foundation initiated by the International Olympic
WADA	Committee to promote, coordinate and monitor the fight against drugs in sports.

## 2 Drug policy

#### 2.1 Guidelines

Telge United FF (TUFF) assumes that all activities performed within TUFF are always free from drugs.

People representing TUFF never appear under the influence of drugs when participating in TUFF related activities. It is never allowed to participate in TUFF's activities under influence of drugs.

No drugs should be present among either managers or players in connection with games, practices, training camps or other similar activities, and not the day before these kinds of activities.

The Swedish Sports Confederation (Riksidrottsförbundet) policy on doping applies. This means that all forms of unauthorized drugs not prescribed by doctors for medical reasons are prohibited from using within the TUFF.

Players should annually be informed about this policy during applicable meetings. It is important that new board members, managers, players and others who work within TUFF understand and adhere to the content of this policy.

#### 2.2 Events

Telge United FF has the right to organize parties and events for sponsors and members where alcohol can be included. However, those responsible should ensure that consumption is moderate, and that no minors are served alcohol.

### 2.3 Doping

Athletes are required to know the WADA doping list, dispensation rules, and the obligation to participate in doping control. Managers and other officials in Telge United FF are also subject to these rules, i.e. not contributing to doping or complicating for officials conducting doping control.

# 3.1 Games, trainings and corresponding

Coaches and individuals who act on behalf of coaches have the right to reject players and managers from games, practices and so on, if suspicion of abuse exists.

### 3.2 Events

Telge United FF (TUFF) has the right to evict a person who appears drug-affected at TUFF events.
